\* Eligibility Requirements for Recent Graduates: An individual who meets the following may apply for the DHA Recent Graduate Program: Was awarded a degree by an institution of higher education not more than two years before the date of the appointment of such person, except that in the case of a person who has completed a period of obligated service in a uniform service of more than four years. The qualifications requirements below must be met in addition to eligibility requirements.

Full Performance Level: Varies (see above) Promotion to the full performance level is contingent upon satisfactory completion of training requirements and continuous satisfactory performance.

Duty Location: U.S. Army Corps of Engineers, Engineering and Support Center, Huntsville, AL

Starting Salary: \$48,483 to \$77,093. In addition to the salary listed, a Special Salary Rate may be included dependent on selected series and duty location. Pay will be based on such factors as the position, your qualifications, education, experience, training, and availability of funds.

Work Schedule: Full-time

Appointment Type: Permanent

<u>Relocation</u>: Relocation (PCS) expenses may be authorized (subject to available budget) if the selecting official determines the relocation is in the best interests of the government.

<u>Hiring Incentive</u>: Hiring incentives such as a recruitment bonus and student loan repayment may be authorized (subject to available budget) if the selecting official determines the incentive is in the best interests of the government.

<u>Qualifications Requirements</u>: Candidates will be evaluated in accordance with the qualification and eligibility requirements set forth by the Office of Personnel Management (OPM) located at https://www.opm.gov/policy-data-oversight/classification-qualifications/general-schedule-qualification-standards.

**Responsibilities/Duties:** As a Recent Graduate Intern, you will be assigned to a senior specialist or group of specialists. You will be assigned tasks designed to familiarize you with different aspects of the occupation. Tasks will vary depending on the senior specialist's current workload, but may include the following:

- 1) Perform basic work in an identified Engineering field, following a prescribed agenda to complete assignments designed to provide an introduction to the field, and an understanding of the organization, program, and policies.
- 2) Complete formal/informal classroom training, on-the-job training, and or self-development to obtain basic knowledge of the principles, theories, reference material and work procedures fundamental to the field
- 3) Participate in a variety of projects using computer skills to provide assistance in evaluating requirements and procedures, assist with the preparation of technical and administrative reports, and interface with senior program officials.

- Must meet suitability for Federal employment
- Will be required to provide proof of U.S. Citizenship

- Will be required to serve a 1-year probationary period
- Temporary Duty Travel may be required
