**In addition to meeting the basic requirement above, to qualify for this position you must also meet the qualification requirements listed below:**

**Specialized Experience for GS-12:** One year of specialized experience which includes: performs engineering design or review activities of electronic security systems; interprets and adheres to engineering principles and policies; and provides engineering construction/project management, or engineering facilities/infrastructure management and services such as design, review, construction, or maintenance of electrical or security systems. This definition of specialized experience is typical of work performed at the next lower grade/level position in the federal service (GS-11).

Some federal jobs allow you to substitute your education for the required experience in order to qualify. For this job, you must meet the qualification requirement using experience alone no substitution of education for experience is permitted.

**Responsibilities/Duties:** Serves as an Electrical Engineer with responsibility for:

1. Receives and responds to a multiple variety of project assignments which consist of both short and long-term engineering projects involving the design and layout of security systems.
2. Manages and coordinates efforts of Architect-Engineer (AE) and Installation Services firms for assigned electronic security system projects under contract to the Huntsville Center.
3. Reviews A/E drawings/contractor shop drawings and specifications for accuracy and completeness. Ensures compliance with accepted design and construction practices and economic feasibility of design.
4. Plans, coordinates, evaluates, and reviews all phases of project control on electronic security projects including the interpretation of and compliance with criteria, regulations, policies, and procedures, design and construction authorization and directives, availability and proper application of funds, and coordination of changes and additions on assigned projects.
5. Acting as a consultant on all problems relating to electronic security systems and provides resolution to problems presented by customers, AE firms and in-house engineers.

### **Conditions of Employment:**

- 1) Must meet suitability for Federal employment.
- 2) Will be required to provide proof of U.S. Citizenship.
- 3) Male applicants born after December 31, 1959 must complete a Pre-employment Certification-Statement for Selective Service Registration.
- 4) Personnel security investigation required
- 5) Must be able to obtain and maintain a Secret Clearance
- 6) Will be required to serve a 2-year probationary period.
